## **ORDINANCE NO. 2018-18**

## AN ORDINANCE TO AMEND SECTIONS 74-1 AND 74-4 AND TO DELETE SECTIONS 74-2, 74-3 AND 74-5 OF THE CODE OF ORDINANCES FOR THE VILLAGE OF UNION GROVE REGARDING THE COMMITTEE ON RECREATION AND PARKS

The Village Board of the Village of Union Grove ordains as follows:

1. That Section 74-1 of the Municipal Code of the Village of Union Grove is hereby amended to read as follows:

## "Sec. 74-1. Committee on Recreation and Parks.

The recreation commission is hereby abolished and its powers, duties and responsibilities shall be conferred on the Committee on Recreation and Parks."

- 2. That Section 74-2, entitled "Terms of office", and Section 74-3 entitled, "Officers; meetings; compensation; technical advice", of the Municipal Code of the Village of Union Grove are hereby deleted.
- 3. That Section 74-4 of the Municipal Code of the Village of Union Grove is hereby amended to read as follows:

## "Sec. 74-4. Powers.

- (a) The Committee on Recreation and Parks shall have the power to:
  - (1) Provide supervision of all recreational and parks activities and programs.
  - (2) Provide general supervision of the activities of the Recreation Director who shall report directly to the village administrator.
  - (3) Prepare and recommend to the village board an annual budget for park and recreation programs.
  - (4) Prepare and recommend to the village board a comprehensive plan of park and recreation improvements, looking to the future development of the village, which plans shall be known as the official plan of the village. Such plan shall include reasonable requirements with reference to all new growth and redevelopment considering park space, recreation areas, green spaces and nature conservancies. The planning improvements are intended to foster community involvement, consolidate and prioritize available funding sources and

develop a strategic vision for parks and recreation facilities within the village.

- (5) Conduct an evaluation of existing codes to ensure future growth and redevelopment are consistent with the comprehensive plan.
- (6) Prepare and recommend to the village board from time to time such changes in the plan as it deems necessary.
- (7) Prepare and recommend to the village board from time to time plans for specific improvements in pursuance of such official plan.
- (8) Aid the village officials in carrying out the program of the recreation commission.
- (9) Recommend park maintenance projects to the Village Board, which shall determine the appropriate source of funding and refer approved projects to the Department of Public Works for implementation.
- (10) Exercise such other powers as may be conferred by the village board or by ordinance or statute.
- 4. That Section 74-5 of the Municipal Code of the Village of Union Grove is hereby deleted.
- 5. That this ordinance shall become effective upon adoption and publication as provided by law.
