### "Sec. 2-165. Bond; liability of village for payment of taxes to county.

- (a) Bond eliminated. The village elects not to give the bond on the Village Finance Director/Treasurer provided for by Wis. Stat. § 70.67(1).
- (b) Liability for default in payment of taxes to county. Pursuant to Wis. Stat. §70.67(2), after March 13, 1956, the Village shall be obligated to pay, if the Village Finance Director/Treasurer shall fail to do so, all state and county taxes required by law to be paid by such Village Finance Director/Treasurer to the County Treasurer."
- 2. That this ordinance shall become effective upon adoption and publication as provided by law.
